

Shared Path facilitates relationship-building opportunities for rights holders, First Nations and local governments, institutions, and organizations for reconciliation through access to resources, research, and education.

## Shared Path's Workshops

- 1. Network and build relationships to bridge Aboriginal and Treaty Rights to land use planning
- 2. Learn about each other, our work, and responsibilities, planning processes in accordance with the Ontario Planning Act and the Provincial Planning Statement, and how to apply the Articles of the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP) and Free, Prior, and Informed Consent (FPIC) into policy.
- 3. Move beyond concerns into collaboration through new communication channels, working relationships, agreements, and new tools for Indigenous-municipal engagement for planning and economic development.

#### Themes:

- Aboriginal Rights/knowledge in Planning
- Understanding changes in Planning
- Building Relationships between FNs & municipalities/CAs

#### Issues:

- Development pressure & info flow
- Collaboration with FNs
- · Capacity deficit: time, funding, staff
- Share expertise/resources/power
- Funding options

#### Problems:

- Poor information sharing
- Volume of work is overwhelming
- Restricted by narrow government focus, legislation, frameworks & timelines
- World views that disconnect us from land/water
- Land speculation lobbying
- Lack of effective FN : CA/municipal engagement
- Staff turnover: loss of institutional knowledge
- Reduced role of CAs
- Other levels of government not listening



## Purpose of an Indigenous Collaborative Hub

Building relationships beyond Duty to Consult

- Meeting Provincial mandates for early engagement
- Establishing a forum for discussion of issues of mutual interest e.g. development visions, Service Agreements, joint funding opportunities




- Bill 23 changes to Natural Heritage

- Repeal of the Growth Plan
- Provincial Planning Statement blends PPS with Growth Plan
  - "The Province recognizes the importance of consulting with Aboriginal communities on planning matters that may affect their section 35 Aboriginal or treaty rights."
  - "The Provincial Planning Statement shall be implemented in a manner that is consistent with the recognition and affirmation of existing Aboriginal and treaty rights in section 35"
- Minister Zoning Orders

## Truth and Reconciliation Commission's Call to Action #92 Business and Reconciliation 92. We call upon the corporate sector in Canada to





- 92. We call upon the corporate sector in Canada to adopt the United Nations Declaration on the Rights of Indigenous Peoples as a reconciliation framework and to apply its principles, norms, and standards to corporate policy and core operational activities involving Indigenous peoples and their lands and resources. This would include, but not be limited to, the following:
  - Commit to meaningful consultation, building respectful relationships, and obtaining the free, prior, and informed consent of Indigenous peoples before proceeding with economic development projects.
  - Ensure that Aboriginal peoples have equitable access to jobs, training, and education opportunities in the corporate sector, and that Aboriginal communities gain long-term sustainable benefits from economic development projects.
  - iii. Provide education for management and staff on the history of Aboriginal peoples, including the history and legacy of residential schools, the United Nations Declaration on the Rights of Indigenous Peoples, Treaties and Aboriginal rights, Indigenous law, and Aboriginal-Crown relations. This will require skills based training in intercultural competency, conflict resolution, human rights, and anti-racism.


## **Purpose of an Indigenous Collaborative Hub**

Collaborative Hubs serve as joint tables for reconciliation and dialogue on cumulative impacts to the land, air, and watershed.

- Collaborate over policy reviews for streamlined approach
  - address capacity deficit: time, funding, staff
- Activate engagement processes as spaces for reconciliation, land management, and dialogue on cumulative impact
- Amend the protection of natural heritage along watersheds to include cultural heritage where First Nations can exercise their inherent rights and authority
- Data and knowledge sharing to improve capacity e.g. Shared Land Map (see sharedpath.ca)
- Develop tools for First Nation-municipal engagement, planning, and economic development
- First Nations can exercise their inherent rights and authority by engaging early in planning, decision making, and shared governance outcomes

#### Next Steps

The SPCI is creating a Collaborative Indigenous Planning Hub Pilot Study for 2025 and is actively seeking partnerships to bring this work together.



## **Proposed Activities**

**Define:** Host kick off meeting in April 2025 with participants

- jointly develop Vision, Mission, Terms of Reference for the pilot.
- **Strategize:** Coordinate second gathering for June 2025
- align on collaborative planning approaches/tools/processes to address key priorities. These will be defined through group discussion and agreement and will define the next step of the pilot Hub.

Test: From July to end of September 2025

• test out preferred approach/tools/processes to explore how these may address the identified priorities of the Hub. Shared Path staff will provide coordination support to assist with uptake.


Evaluate: Gather in October 2025

• First Nations, County, and Town planners and staff part of the Indigenous Collaborative Planning Hub Working Group evaluate approaches and align on approach/tools/processes to support facilitation and greater inter-nation collaboration.

**Next Steps:** Final meeting in December 2025 to provide a dynamic presentation of what was accomplished, review the final report, celebrate our successes, and plan for next steps.

## **Requested Action**



\$120,000 is needed to deliver on the Indigenous Collaborative Hub.

To date, Shared Path has received a funding commitment of \$35,000 from the Ontario Professional Planners Institute (OPPI) – contingent upon securing matching funds.

**Ask:** \$10-25k in matching funds for Indigenous Collaborative Hub pilot for 2025 and possible 2026 continuation.

#### Purpose: Formation of an Indigenous Collaborative Hub

The Shared Path Consultation Initiative (Shared Path) is a charitable organization started in 2017 that seeks to bridge Indigenous and municipal planning systems to support the expression of Aboriginal and Treaty Rights in land use decision making in Ontario.

Through the support of The Department of Canadian Heritage, the Shared Path hosted a series of workshops (3) entitled "Our Shared History" culminating in an in person workshop on June 26th with over 40 participants from First Nations, upper and lower tier municipalities, and conservation authorities. This next step/recommendation was to create a pilot program over 1 to 2 years for an **Indigenous Collaborative Hub** to advance relationship building, coordination, data and knowledge sharing, and collective capacity.

The Hub would explore and model governance of the land and waters through First Nations perspectives and engagement in community planning and economic development without overburdening communities. It will follow the precedent set by the Muskoka Area Indigenous Leadership Table (MAILT). The project outcomes include developing: an ongoing relationship building process and a forum for discussion of issues of mutual interest.

#### Requested Action from Council

Consideration of funding for pilot 2025 and possible 2026 continuation for Indigenous Collaborative Hub.

The following sections outline the proposed work plan, timelines, expected deliverables, and desired contribution.

#### **Proposed Work Plan**

The pilot will take place through a series of facilitated in person / virtual sessions over the course of 2025 and possibly into 2026. The hub will take shape through the following proposed steps, and adapt as needed:

- 1. **Define**: Host kick off meeting in April 2025 with participants and establish the Vision, Mission, Terms of Reference for the pilot. This will be an information gathering session on the core relationship wants, needs and priorities based on how things work now and where change needs to take place.
- 2. **Strategize**: Coordinate second gathering for June 2025 to strategize on collaborative planning approaches/tools/processes to address key priorities. These will be defined through group discussion and agreement and will define the next step of the pilot Hub.
- 3. **Test**: From July to end of September 2025, test out preferred approach/tools/processes to explore how these may address the identified priorities of the Hub. Shared Path staff will provide coordination support to assist with uptake.



- 4. **Evaluate**: Gather in October 2025 to assess the outcomes of the testing period of the preferred approaches/tools/processes and compare to the needs and priorities expressed at the initial gathering to assess the impact.
- 5. **Next Steps:** Final meeting in December 2025 to provide a dynamic presentation of what was accomplished, review the final report, celebrate our successes, and plan for next steps moving forward into 2026.

#### **Expected Results and Evaluation Plan**

<u>Short-term</u> – the 15-30 workshop participants will receive briefing notes with decisions and next steps after each session. During the session they will gain knowledge regarding the feasibility of a "Hub" for discussing and resolving issues of mutual concern, and the improvement of existing institutional practices.

<u>Medium-term</u> – at the end of the project, the participants will have a better understanding of processes and models for including First Nations in decision making regarding land-use and planning. The indicator of the project outcomes will ultimately be measured by whether or not the Collaborative Planning Hub is established:

- as a normal part of the ongoing relationship building process
- as a forum for discussion of issues of mutual interest
- as a mechanism for land use decision making

Shared Path will conduct an assessment following the fourth meeting of the Indigenous Collaborative Hub Whether the participants agree to continue to collaborate will be the primary indicator of success. Indigenous Collaborative Hub Members will have an opportunity to review, suggest changes, and approve the assessment – this will also be reflected in a final report and possible toolkit or booklet.



#### **Requested Contribution and Use of Funds**

To achieve this work, the Shared Path will support capacity funding for First Nations participation and is seeking \$120,000 over 1 or 2 years from all funders. To date, Shared Path has received a funding commitment of \$35,000 from the Ontario Professional Planners Institute (OPPI) – contingent upon securing matching funds. We are kindly seeking matching funds in the amount of 10-25K, to secure OPPIs investment for 2025, and consideration of funding to continue the Hub into 2026.
