Designating Redwing as a Community Safety Zone will:

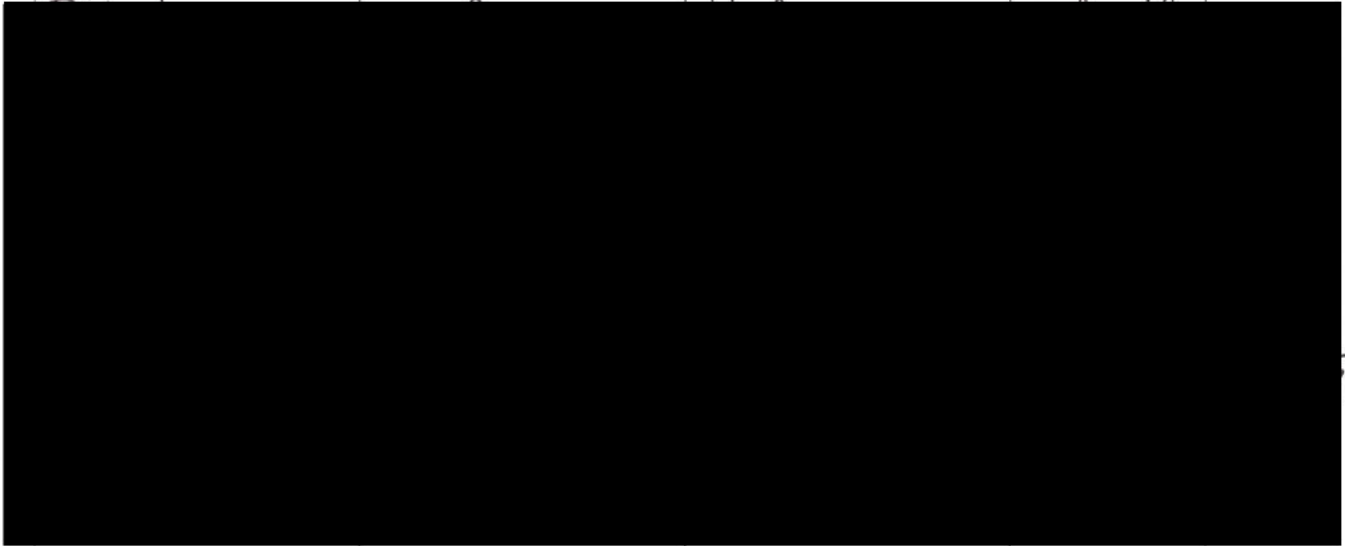
- Enhance enforcement of traffic laws
