C. Matters for Discussion

C.1 Grey Bruce Vaccination Update – Mayor Alar Soever

- **Progress**
- **Seniors' Experience and Feedback**
- Mayor Soever shared information from Dr. Ian Arra, Grey Bruce Public Health, which confirmed that Grey Bruce is expecting 3,500 to 5,000 vaccines per week and receives confirmation of vaccines 4 weeks in advance
- Vaccine clinics will be available in Grey Bruce every week going forward
- Mayor Soever will continue to work with Dr. Arra to advise of the issues experienced by seniors

Pamela McDermid was unable to join the meeting due to technical difficulties but provided the following comments regarding vaccinations for seniors following the meeting:

- There are many glitches in the booking system for vaccinations and seniors are being sent to fairly far flung clinics. One Meaford resident was persistent and argued for destinations that were closer to home and ended up being assigned to Collingwood. That was after she rejected Pentanguishene, Hanover & Kincardine.
- Someone said, “well at least they are getting the vaccination.” This completely ignores one of the factors which are salient for many seniors and that is a lack of access to personal transportation. Just as there is a higher likelihood of seniors having phones than computers & internet, there is a higher likelihood of seniors not being able to drive themselves and having to rely on public transit which is scarce, must be booked ahead and has very limited schedules.
- The Other item that I wanted to raise was the Preventing Senior Abuse series that we are starting on April 8th.
- It is tangential to COVID-19 recovery, however the unprecedented increase in calls to the Seniors Safety Line since the pandemic began, has increased our awareness of how important it is to address this problem in our community and across Grey and Bruce, Ontario, and Canada.

C.2 COVID-19 Update – Mayor Soever

- COVID-19 cases in Ontario and Grey Bruce are trending upwards
- Mayor Soever noted his belief that Grey Bruce likely will not remain in the Green zone based on the case trending
- Mayor Soever reviewed the number of active cases on March 1, 2021 and March 30, 2021 in Grey Bruce
March 1, 2021: 12 active cases, 31 high risk contacts, and 2.6 contacts per case
March 30, 2021: 58 active cases, 437 high risk contacts, and 7.5 contacts per case

C.3 South Georgian Bay Tourism Recovery Task Force – Councillor Sampson

- A provincial Task Force has been established to put forward tactics to support the tourism industry once COVID-19 lockdowns are lifted – Councillor Sampson sits on this Task Force
- Councillor Sampson received Council’s approval to establish a South Georgian Bay Tourism Recovery Task Force comprised of municipalities and stakeholders to make recommendations to the larger provincial Task Force by mid-April 2021
- Councillor Sampson noted that if any members of the Community Recovery Task Force have suggestions or recommendations, to provide them to staff

- Library staff have been assisting qualifying individuals to register for the COVID-19 vaccine upon request
