A. Recommendations

THAT Council receive Staff Report FAF.21.056, entitled "Follow up to the Public Meeting for Revisions to Council Delegation of Powers and Duties";

AND THAT Council direct staff to draft new or revise existing by-laws related to the delegated authorities listed in the Town's Corporate Policy POL.COR.07.04 Delegation by Council of Powers and Duties.

B. Overview

This report outlines the public comments received at the February 8, 2021 Public Meeting for the proposed revisions to the Corporate Policy POL.COR.07.04 "Delegation by Council of Powers and Duties".

C. Background

On December 14, 2020, Council directed staff to hold a Public Meeting to receive comments on the Town's proposed revisions to the Delegation by Council of Powers and Duties policy outlined in staff report FAF.20.188 (Attachment 1).

Notice of the Public Meeting was posted to the Town's website on January 4, 2021 and advertised in three editions of the Collingwood Connection online publication (January 7, 21 and February 4, 2021).

D. Analysis

On February 8, 2021, the Public Meeting was held as scheduled. One written comment was received (Attachment 2) requesting that reference to the legislative documents that grant Council its authorities be added to the list of delegated authorities.

No verbal comments from the public were received during the meeting.

Council requested that staff create delegated authority decision tree flow diagrams to better illustrate the processes and the points at which the various delegated authorities are applied.

Staff have provided the delegated authority flow diagrams and references to the legislative documents associated with each delegated authority in Attachment 3 to this report.

If approved by Council, staff recommend that the existing by-laws related to the delegated authorities listed in the Town's Corporate Policy POL.COR.07.04 Delegation by Council of Powers and Duties" be revised to incorporate the revisions included in Attachment 3. Staff also recommend that a new by-law be drafted for the new delegated authority regarding relief to the Town's Noise By-law as outlined in Attachment 3. These draft by-laws would be presented to Council at the May 4, 2021 Committee of the Whole meeting.
