C. Matters for Discussion

- C.1 Trespassing as it relates to food safety, security and liability Director of Legal Services Will Thomson, Committee members Rosemary Mesley and Dennis Ouellette
 - Ontario Federation of Agriculture article "Trespass problems? Tips on how to deal with Trespassing" (provided by Rosemary Mesley)
 - Security from Trespass and Protecting Food Safety Act, 2020
 - Ontario Federation of Agriculture article "Security from Trespass and Protecting Food Safety Act"

Director of Legal Services Will Thomson spoke regarding the *Security from Trespass and Protecting Food Safety Act* which arises from trespassing issues on private farm properties and potentially interfering with the transport and processing of livestock. Will explained that the *Act* replaced the *Trespass to Property Act* and places more onerous penalties on those trespassing onto farm property, specifically "Animal Protection Zones". Farmers can define these "Animal Protection Zones" which prohibits individuals for entering. For clarification purposes, the *Trespass to Property Act* does still remain in force and effect for trespassing in other circumstances.

Committee member Dennis Ouellette requested clarity regarding whether the legislation also includes orchards and cash cropping properties. Councillor Matrosovs noted that the legislation is relevant to lands under cultivation and orchards.

With respect to regulations, Ontario Regulation 701/20 has been developed. Will committed to confirming whether the regulations are currently in force.

Committee member Duncan McKinlay enquired whether there is onus on the average member of the public to be aware of trespassing laws and what does, versus does not, constitute trespassing. Will noted that a property does not need to be signed for trespassing to occur.

Councillor Matrosovs noted that often these issues are not simple matters of trespassing and pointed out that often, people feel entitled to explore an apple orchard however, this constitutes a hazard as there are checks and balances that define who may enter an orchard to assist with food safety.

C.2 Responsibility of "Livestock at Large without supervision"

NOTE: Council provided the following direction at the January 27, 2021 meeting:

THAT Council of the Town of The Blue Mountains receives the November 19, 2020 Agricultural Advisory Committee recommendation as noted below:

THAT with respect to Item C.4 Livestock Escapes Discussion and Role of Agricultural Advisory Committee, the Agricultural Advisory Committee recommends that Council provide resources to the Agricultural Advisory Committee regarding the issue of "livestock at large without supervision" with the goal of exploring education and coordinated responses, CARRIED.

AND THAT Council approves the request for resources for the Committee regarding the issue of "livestock at large without supervision" and forwards this matter to By-law staff for review with the Committee with the goal of exploring education and coordinated response, CARRIED.

Will Thomson noted that the Ontario Provincial Police is the response body for livestock at large, and further explained that the *Pounds Act* allows for pounds keepers however, The Blue Mountains does not have designated pounds keepers. The Committee reviewed an advisory note circulated by the Grey County Cattlemans' Association as developed by the Ontario Ministry of Agriculture, Food and Rural Affairs.

Committee member Duncan McKinlay noted that though there is no pound keeper, any property owner can impound animals at large and advise the Town Clerk. Will noted that he will confirm and follow-up. Duncan questioned if the municipality or province assumes some liability for impounded animals if a private property owner has taken them in, or whether the private property owner is liable. Will further noted that the Act speaks to the liability of the animal, but noted he will have to do some follow-up.

C.3 2021 Wild Chervil Update - Director of Operations Shawn Carey (verbal)

Director of Operations Shawn Carey referenced a letter that was circulated to the Committee regarding outreach and education for private property owners where it is believed there is wild chervil. It was requested that Committee members send any individuals comments or feedback to By-law Supervisor Wayne DeWitt. Shawn further noted that the Town's approach to use "spot spraying" is proving challenging as local contractors are advising they do not have the capacity for this method of wild chervil mitigation. Shawn confirmed he will provide further updates as available.

Committee member Duncan McKinlay questioned whether the Town could work with university students to pilot a research program that relies on technology to mitigate wild chervil. Committee members John Ardiel, Grant McMurchy, and James McKinlay offered contacts for programs that use drones to spot spray horticultural crops. Committee member Dennis Ouellette enquired whether spraying can be conducted in house. Shawn noted that the licensing and resources required for in-house spraying, but further evaluation in the future could be warranted. James noted that a demonstration site for wild chervil management would still be a good idea if possible.

C.4 Heritage Apple Variety Nursery

C.5 Parking Update - By-law Supervisor Wayne DeWitt

By-law Supervisor Wayne DeWitt noted the Parking By-law has been revised as a result of increased use of recreational areas due to COVID-19. This has led to a number of "no parking" areas throughout the Town. Wayne noted key challenges of the revised parking legislation is that the community appears split 50/50 for/against and installation of signage is prohibitive. Director of Operations Shawn Carey noted a multi-jurisdictional and pronged approach to parking management is required. Wayne noted that if parking issues are reported, by-law staff will respond.

Committee member Duncan McKinlay enquired whether the Niagara Escarpment Commission has been contacted for Metcalfe Rock parking area, Shawn replying that a permit from the Niagara Escarpment Commission is not required. Wayne further noted that there is a recommendation for parking fines to increase to further dissuade individuals from parking in "no parking" areas. Wayne noted he will confirm that parking ticket prices are posted to the Town's website.
