The event should be similar to 2020 with a drive thru option, and a sit down option, pending COVID-19 regulations. Councillor Sampson noted that tax receipts are being organized by St. George's Anglican Church for a \$2,500 fee.

Committee member Linda Wykes advised that to date, 23 dinners have been purchased, and the event has raised approximately \$2,000 in revenue. The event has also been advertised through The Blue Mountains Review.
