A. Recommendations

THAT Council receive Staff Report FAF.21.094, entitled "Vacant Unit Rebate Program Elimination";

AND THAT Council pass a By-Law to eliminate the "Vacant Unit Rebate Program" for business properties.

B. Overview

Grey County Council received Report No. FR-CW-10-21 "Vacant Unit Rebate Program" at their March 25, 2021 meeting. A copy of the report is attached. County Council supports the elimination of this program and circulated the report to local municipal councils in the County for their information, consideration and possible action.

C. Background

The Vacant Unit Rebate Program provides eligible business properties in the commercial and industrial classes with the ability to apply for a percentage rebate for the tax levied on vacant space. The rebate percentages are 30% and 35% respectively.

In order to qualify for a rebate there are a number of eligibility requirements that must be met, including:

- the area must be vacant for a minimum of 90 consecutive days;
- the area must be physically separated from the used portions of the building;
- the business must not be seasonal in nature; and
- the area must be capable of being leased for immediate occupation or undergoing renovations.

In late 2020, the Municipal Act was changed to enable local municipalities to pass a by-law to eliminate the rebate.

D. Analysis

The vacant unit rebate program has become increasingly problematic for various reasons including:

- Properties remaining eligible for rebate program for years at a time or indefinitely;
- Properties that have received rebates after securing assessment reductions;
- The application and enforcement of eligibility criteria are difficult to administer due to loosely defined rules and limited compliance provisions.

As shown in the table below, in The Blue Mountains, the historical impact of the rebate program to Town revenue has been minimal, usually under \$1,000. From 2016 to 2019, the aberration was due to the vacant former Foodland.
