#### A. Recommendations

#### B. Overview

This report requests that Council enact a By-law to appoint Caroline Krasniewski, Jerome Miller, and Emily Reid as Municipal Law Enforcement Officers for the purposes of enforcing by-laws of the municipality.

#### C. Background

Three, four-month Municipal Law Enforcement Officer (MLEO) positions were posted in May to fill a need for additional By-law support during the summer season. Two of the positions were to add to our current number of By-law Officers, and one was to replace an existing position that was recently vacated. The positions were filled externally, and employment of the successful candidates, Caroline Krasniewski, Jerome Miller, and Emily Reid, commenced June 11, 2021.

### D. Analysis

Council must approve the enactment of a By-law to authorize Caroline Krasniewski, Jerome Miller, and Emily Reid to be able to enforce the By-laws of the municipality. As the appointment of these Officers is time sensitive, this Report and associated By-law have been expedited directly to this Council meeting.
