B. Overview

This report provides the details of seven requests for relief from the provisions of the Noise Bylaw for Council's consideration.

C. Background

The Town is in receipt of seven applications requesting relief from the provisions of the Noise By-law (Attachment 1) for weddings taking place on the dates listed below at Georgian Hills Vineyard – 496350 Grey Road 2; each request is from 4:00 p.m. to 12:00 a.m. It is noted in the applications that the DJ will turn the bass and volume down at 11:00 p.m. and then stop playing music at 12:00 a.m.

These applications were submitted by Amanda Jerome Weddings & Events who regularly organizes weddings and other events at Georgian Hills Vineyard. The owner of Georgian Hills

Vineyard has provided authorization (Attachment 3) for Amanda Jerome to submit applications for such events at this property. The requested dates are:

- Saturday, July 17th
- Friday, July 23rd
- Saturday, July 24th
- Saturday, August 14th
- Friday, August 20th
- Friday, September 17th
- Saturday, September 25th

D. Analysis

Section 3e) of the Noise By-law permits the making of noises or sounds related to the non-residential use of land permitted by a by-law enacted by the municipality pursuant to the applicable Zoning By-law from 07:00 to 19:00.

It is noted that outdoor events in themselves outside of 07:00 to 19:00 are not prohibited. The making of noise is prohibited in the instance where such events are likely to disturb the peace, quiet, comfort or repose of any inhabitant.

In accordance with the procedures set out in our Policy & Procedures for Noise By-law Relief Requests, notice to the residents within 120 metres was circulated. Due to the timing of the application, the deadline for residents to submit comments exceeds the date of submission for this report. As of the date of submission of this report no responses were received, however, any additional information will be provided by a representative of the Enforcement Services Department at the Committee of the Whole meeting on June 29, 2021.

Staff is recommending that Conditional Relief to the Noise By-law be granted on the conditional basis being that all requirements set by the Province of Ontario in relation to COVID-19 Restrictions and including where necessary approvals required by the Grey Bruce Health Unit and Alcohol and Gaming Commission (AGCO).
