B. Staff Reports and Deputations

B.1 Deputations, if any

B.1.1 Michele Hunter, Program Manager for Rural Ontario Medical Program ("ROMP")

Re: Overview of the Rural Ontario Medical Program and Upcoming Events

Committee Member Barb Clumpus joined the meeting at 10:08 a.m.

Chair June Porter welcomed Michele Hunter, Program Manager for Rural Ontario Medical Program (ROMP).

Michele provided an overview of what ROMP's work is focused on, where do we start, what can we do, what has changed for Canada's healthiest community, and discovering the numbers.

Michele advised that ROMP is focused on continued learning with clinical clerks, post graduate residents and preceptors (late-career phase), as well as virtual training.

Michele advised that as ROMP partners with communities to consider the things that can be done to calibrate the information cascading out to physicians through the work of the Committee or other candidates, it would be beneficial to also emulate what other communities have done where they have been successful.

When considering how to expand into communities, ROMP considers what medical students are doing with other initiatives while they are back home in our communities.

Michele noted that the Town has invested funds for video content, but that that content needs to be broadly linked so it is more available and provides individuals an opportunity to experience the community.

Michele provided an overview of healthcare impact of training in South Georgian Bay Region with the goal to expand into other areas.

Michele provided an overview of the CSJ 2021 Grant and advised it was the largest in the province.

Michele advised the Committee that ROMP is hosting a ROMP Research and Innovation Day on June 16, 2021 from 9-11:30 a.m., and that the theme is COVID Wellness. Michele advised that archived ROMP events are available on the ROMP website for other topics including cancer and geriatric issues.

Committee Member Yvonne Hamlin noted that previous speakers at the Committee level had indicated that the doctor-to-patient ratio was at 1,250/1, but that it should be closer to 800/1. Michele confirmed that the 1,250/1 ratio is a Ministry number, but that the lower ratio is what is being adopted in practice. Michel advised that those ratio discrepancies are being addressed this summer with students.

Yvonne noted that Collingwood has set up an affordable housing taskforce and asked if that would be the kind of thing ROMP would attend to speak at regarding community needs and how to handle it, which Michele confirmed.

Committee Member Barb Clumpus noted the importance of broadening access to primary care and relieving the discrepancy between the

number of medical practitioners leaving and the incoming doctors who are replacing them. She advised that the Meaford Community Safety and Wellness Plan, which focuses on social determinants of health, is finishing soon. Barb asked whether Michele has any information on how allied professionals will be funded. Michele advised that ROMP is involved in all the training to the point where the practitioners are in their final residency or practicum, and that the location choice is made by the resident, nurse practitioners or learner as to where they will practice. Michele advised that it is important to have information available to assist with that decision-making.

Councillor Sampson noted that this Committee should be addressing any assistance to the Collingwood doctor-cap, and the importance of how to understand where the Town fits within the continuum of retaining physicians within the community. Councillor Sampson noted that this presentation may be beneficial to The Blue Mountains Attainable Housing Corporation. Michele advised that pre-COVID, doctors were leaving their families to reside in apartments in the city and see patients. Now, doctors are not mobilizing with the provincial restrictions in place to explore, but they are doing so virtually. Michele noted that individuals coming out of residency and medical students are doing everything online. Michele advised that it would be good to collate available information and link to one another.

Committee Member Doug Measures noted that the area is being investigated by potential new residents, by physicians and others digitally and the importance of being digitally approachable.

Chair Porter thanked Michele for her presentation to the Committee.

C.2 Update on Question and Answer Series - Chair Porter

Chair Porter advised that the media release regarding the first of the Question and Answer series occurred the previous week and noted she had not seen anything from local press. Chair Porter advised she is currently working on the second publication along with a summary powerpoint presentation and asked if there were any comments regarding bringing this to the participating municipal Councils for comment.

Councillor Hamlin asked whether the power-point summary of the survey results could be made available to Committee members, and Chair Porter confirmed the presentation would be made available and the agenda item would be brought forward to the next few Committee meetings. Chair Porter advised that she would circulate the material accordingly.

Councillor Tom Allwood noted that the media releases should be attached to the Minutes so that same can be provided to respective Councils for consideration. Chair Porter asked Executive Assistant Committees of Council Sarah Merrifield how to approach this issue. Sarah advised that the approved minutes can be circulated immediately following the meeting and confirmed that the news item can be circulated.

Councillor Sampson noted that it would be beneficial to engage a physician recruiter to help work with ROMP. Councillor Sampson noted the need for a possible amendment to the committee structure to take the Committee into the future as a separate legal entity.

Chair Porter advised that the Committee had the option to hire a physician recruiter in a standard contract to get up and running.

Councillor Hamlin inquired as to how the Midland recruiter was hired. Chair Porter advised the recruiter was a self-employed individual hired through contract and advised he may have been hired under an RFP process.

Mayor Doug Measures noted his agreement with Councillor Sampson that the Committee needs to move forward with the recruiter process. He noted his thanks to The Town of Blue Mountain Council, CAO, the Administration Department and the Clerk's staff for continuing to provide support. He noted the structure of the Georgian Bay General Hospital which is operated by hospital and supported by municipalities as a model to consider. Committee members discussed creation of sub-committees.

Mayor Measures left the meeting at 11:48 a.m. and rejoined at 11:53 a.m.
