The rising number of cyclists using 10th line in Collingwood/Clearview to access Pretty River Rd (Town of Blue Mountains) is becoming a real safety hazard for both cyclists and motorists. I reside in Collingwood but hike daily in Pretty River and the number of cyclists riding on these roads with may blind spots and no shoulder is surely going to result in a death sometime soon. Every weekend, the number of cyclists riding 3 and 4 abreast uphills and down is causing many near misses. I tried calling the OPP to better patrol the roads but they told me it is not a police issue but a municipal issue.
