# C.1 Grants and Donations Application Criteria Subcommittee - Committee Member Michael Caron (verbal)

Committee member Michael Caron provided a summary of a recent Grants and Donations Application Criteria Sub-committee meeting. The sub-committee reviewed and developed key criteria for first review of program applications, being a suggested not-for-profit organization that benefits The Blue Mountains residents, and number of residents wo benefit from the organization, along with financial need. At the next sub-committee meeting on September 15, 2021, the sub-committee will consider additional criteria for review and also retroactively review the 2021 program recipients.

Committee member Caroline Harbinson joined the meeting at 1:15 p.m.

The Committee discussed that Council will need to endorse any changes to the application criteria before it can be used in the 2022 intake.

It was noted that criteria for the Committee's consideration should be available for the October 1, 2021 meeting.

Director of Finance and IT Services Ruth Prince advised the community has been very interested and thankful for the second 2021 grant intake opportunity. The applications close Friday, September 10, 2021 with review at the Grants and Donations Committee October 1, 2021 and Council's final direction following the Committee's review.

Councillor Bordignon reported that daytime Oktoberfest activities will be provided by the Marsh Street Centre and the Legion, with live music and barbeque. It was noted that Clarksburg Village Association should be contacted

to ensure other Clarksburg businesses are included in the festivities. Additional beauty bags were requested from Marc Anthony Venere and will be prepared. The night event will include a traditional Oktoberfest dinner experience.

It was discussed that sponsorships will be needed where possible to cover approximately \$2,500 in hard costs. Marc Anthony Venere noted he will donate \$1,000 however, he is concerned that donors who have provided prior funds might be burned out.
