C. Background

As is required by section 88.18 of the *Municipal Elections Act*, on or before May 1 of an election year, the municipality shall establish rules and procedures with respect to the use of municipal or board resources during an election campaign period. Section 88.18 is included below for reference:

Use of municipal, board resources

88.18 Before May 1 in the year of a regular election, municipalities and local boards shall establish rules and procedures with respect to the use of municipal or board resources, as the case may be, during the election campaign period. 2016, c. 15, s. 56.

Minor amendments are recommended to the current Policy, including:

- 1) updated nomination date, now being the third Friday in August
- 2) the inclusion of reference to any "by-election"
- 3) the inclusion of a Schedule "A ", "Election Year Activity Frequently Asked Questions" as developed by the Town's Integrity Commissioner, Suzanne Craig
