B.1.1 Alex Hector and Michael Barrett, Grey Bruce Ontario Health Team Re: OHT Overview and Next Steps

Acting Executive Assistant to Committees of Council Kyra Dunlop advised that the deputants had sent regrets for the meeting. The Committee discussed extending an invitation to attend a future meeting and the benefit to receiving a deputation from neighbouring Ontario Health Teams.

Chair Porter noted that she had questions relating to plans for senior care and mental health based on the presentation provided.

Councillor Hamlin asked how the region had two Ontario Health Teams and whether there would be an impetus for an Ontario Health Team to service the area the member municipalities represented. Chair Porter noted that the existing Ontario Health Team's had applied for funding several years ago and that the boundaries for Ontario Health Teams were overlapped more than previous models.

C. Matters for Discussion

C.1 Rural Ontario Municipal Association Ministry of Health Update - Councillor Sampson

Councillor Sampson advised that the Town had brought forward three items to the Minister of Health during their delegation at the Rural Ontario Municipal Association Conference:

- Electronic registration of COVID vaccinations had been a hindrance to increased vaccination numbers;
- Thanking Minister for the recent designation of Collingwood as an Area of High Physician Need; and
- Deliver action on the whole area being declared an area requiring primary care physicians.

Councillor Sampson advised that the Town had brought a proposal to the Ministry regarding either expanding existing Family Health Teams in the area or creating a new Family Health Team.

Chair Porter noted that through meeting with Greg Powers at the Ministry that it had been identified efforts were best focused on expanding existing Family Health Teams rather than creating new ones given the administrative complexity, and therefore increased costs, of setting up new Family Health Teams.

Councillor Allwood noted that the proposed pilot project had been well received given that the County of Renfrew had done a similar pilot project that was successful.

C.2 Family Health Team Unit Update- Chair Porter

Chair Porter advised that she and Councillor Hamlin had met with Grey Powers regarding next steps in expanding or creating new Family Health Teams and that it had been identified that the focus should be on expanding existing Family Health Teams.

Councillor Hamlin asked how a Family Health Team differed from the Ontario Health Teams. Chair Porter advised that Family Health Teams were a locally organized model of healthcare and have one or more Family Health Organizations associated with them. Ontario Health Teams are a larger umbrella organization which focused more on the coordination of care.

Councillor Sampson noted that the recent data from Census Canada showed significant growth in the area, and that all member municipalities were high on the list of regions that were quickly seeing population growth. Councillor Sampson noted that the Town of The Blue Mountains was identified as the second fastest growing municipality in Canada. Councillor Sampson noted that

the growth pressures facing the region should be referenced in presentations to the Ministry of Health to support Committees' requests for more physicians.

C.3 Municipality of Grey Highlands Council Meeting Update - Councillor Allwood

Councillor Allwood advised that the Committee White Paper had been discussed at the Municipality of Grey Highlands Committee of the Whole and that they had passed the following resolution:

That the Committee recommend to council that staff investigate potential support from Southgate, West Grey, and Chatsworth to join Grey Highlands in setting up a Doctor recruitment and retention committee.

Councillor Allwood noted that Council had also received deputations from the Post Office Union pertaining to elder-care services and check-ins, and from Southeast Grey Community Health Centre regarding a request for additional funding to increase medical staff and access to primary care services.

CAO Everitt noted that depending on the timing of other municipal Council discussions that an update may not be available until the Committee meeting in April. CAO Everitt noted that it was important to provide other municipalities the opportunity to be involved in the process if they would like to however the level of commitment from member municipalities' Councils regarding the Committee was needed.
 - It was discussed that a draft governance structure and the Committee's recording of the meeting could be circulated to Chief Administrative Officers to assist in understanding the direction the Committee intended.
 - The Committee discussed the need for stakeholders, including doctors and business associations, to be at the table. CAO Everitt noted that the South Georgian Bay Tourism Association structure may be a good model to consider.
 - The Committee members would provide CAO Everitt a list of key stakeholders in their municipalities.
