Request for Information Interview

- We would like to conduct **30-minute interviews with 7 to 8 business owners** who use the Town's waste management services.
- The purpose of the interviews is to:
 - Understand what businesses are already doing to embed circularity into their operations.
 - Learn about current challenges related to managing solid waste.
 - Gain insights on how the Town could support small businesses within the community.
 - Determine next steps for moving the circular economy agenda forward.

Interview Questions

- 1. Has your organization taken steps to minimize/reduce solid waste and/or promote circularity?
- 2. Does your organization take advantage of municipal services to manage your waste? For example: Garbage, Recycling, Compost or Reuse programs?
- 3. Does your organization utilize private service providers to manage waste?
- 4. Do you collect/track solid waste management data?
- 5. What are your primary sources of waste? Which materials do you throw away or recycle the most?

- 6. Do you face challenges regarding solid waste management?
- 7. What opportunities do you see in your organization and/or in the community to reduce waste and progress toward a more circular model?
- 8. Would support from the Town of The Blue Mountains help with solid waste management/circular economy efforts?
- 9. What information would be most helpful for you in a waste planning implementation guide?

10. On a scale of 1 to 5, how likely are you to participate in or implement the following circular economy initiatives?(1 = highly unlikely to 5 = highly likely)

- Sharing, repair, reuse, donation programs.
- Circular procurement.
- Food rescue programs.
- Closed-loop system (e.g. onsite composting for onsite fertilizer).
- Reusable packaging.
- Community collaboration, networking.
